The position(s) listed below are to be filled by Election at OCEA's 2022 Annual Business Meeting (ABM) being held on **June 13, 2022**, online via Zoom.

Bylaw 4.1 Only **STATUTORY MEMBERS** in good standing with the Ontario College of Teachers holding a minimum of AQ Part I in Cooperative Education shall have the right to run for and hold office as a member of the OCEA Leadership Team.

Bylaw 5.4 Nominations must be submitted to the chairperson of the Elections Committee at least seven (7) days prior to the ABM.

THE FINAL DATE TO SUBMIT NOMINATIONS FOR THE 2022 OCEA ELECTION IS JUNE 6, 2022.

Bylaw 5.4.1 All nominations must have a nominator and seconder and include the Approval Form.

Bylaw 5.4.1.1 Nominators and seconds of nominations for the Director-at-Large positions must work in a school board the nominee is proposed to represent.

Bylaw 5.4.1.2 Nominators and seconds of nominations for the Provincial Representative positions must be from the linguistic and geographic region the nominee is proposed to represent.

Bylaw 5.5 The chairperson of the Elections Committee shall cause the list of nominees to be published electronically three (3) days prior to the ABM.

Bylaw 5.6 Nominations from the floor at the ABM shall only be accepted for positions where there are no on-time nominations.

NOTE: OCEA PROVINCIAL REPRESENTATIVE NOMINEES should note that they are required to attend the Sunday portion of the OCEA Leadership Team (OCEA Board of Directors and Provincial Representatives) meetings, as well as the fall symposium and spring conference, including the OCEA Board meetings preceding these events. OCEA covers 50% of the costs for symposium and conference registration and accommodation, as well as expenses for meals and travel. Any other expenses incurred will be the sole responsibility of the individual **OCEA PROVINCIAL REPRESENTATIVE**, their district school board or school.

The nominee **MUST** secure the signature of his/her employer (normally the immediate supervisor) as an indication that the employer is aware of the commitment needed from the member for this volunteer position on the OCEA Leadership Team.
